Dear Mr. Banford,

As you are aware, Conectiv Mid-Merit, LLC continues the construction of its 545 MW Combined Cycle Power Plant in Delta, Pennsylvania. The construction of this facility, which includes more than 1.1 million labor hours, is being executed utilizing unionized craft affiliated with the Central Pennsylvania Building and Construction Trades Council of which the Boilermakers for Local Lodge 13 are members. This letter is offered to share with you the project benefits attributed to the use of this unionized craft and more importantly to your interests, the services rendered from the members of Boilermaker Local Lodge 13.

To date on the Conectiv Project, over 750,000 craft labor hours have been completed. Site craft levels have deviated from nominally 250 – 400 over the past year with Boilermakers Local Lodge 13 site participation varying from 40 – 80 members through the year. Critical work scopes completed by your organization to date include and are not limited to the receipt, rigging, setting, fitting and weld out of twenty-seven (27) Heat Recovery Steam Generator modules each with a nominal weight of 200,000 pounds (9 for each HRSG), receipt, rigging, setting, fitting and weld out of six (6) steam drums, the erection and weld out of three (3) Heat Recovery Steam Generator exhaust stacks each with a elevation of 188 feet above grade, the fabrication of the Steam Condenser Shell, the assembly and rigging of Steam Condenser modules and water boxes, the assembly, erection, fabrication and weld out of the three (3) Combustion Turbine Generator set inlet filter houses, combustion air ducts, and exhaust diffuser cones, and the erection of field storage tanks including a four (4) million gallon double walled oil storage tank, a four (4) million gallon demineralized water storage tank, a two-hundred (200) thousand gallon raw water storage tank, a three-hundred (300) thousand gallon service water tank, and a sixty (60) thousand gallon condensate storage tank. All proof testing completed to date has not identified any failures due to workmanship.

The members of the Boilermakers Local Lodge 13 on the Conectiv Delta Site as a group have represented your organization well and sustained a level of professionalism and commitment to safety aligned with your established objectives. Even through the severe winter of 2009 – 2010, your members' participation sustained and the project has been able to stay on track from both a schedule and cost basis. This accomplishment, which is atypical in the construction field, can be accredited to the work force. The quality of work on this site continues to meet or exceed expectations and overall, the workforce is well trained, disciplined, and cooperative.

Thank you for your personnel commitment to date and the contributions of Boilermakers Local Lodge 13 to ensure the success of this project. Your efforts and the allegiance of your members to the success of the Conectiv Delta Project are greatly appreciated.
