MOST BDS Requirements Effective January 1, 2016 Recently adopted changes to the national referral rules require members to meet a list of minimum criteria to be eligible for dispatch from the primary list starting January 1, 2016. If you need any classes please contact the union hall as soon as possible to register for the next available training session. Be sure to visit the local's website for updates to the training schedule.

Monthly dues Monthly dues increased to \$44.40 per month effective January 1, 2016. Remember to put your registration number on your check. Due to security concerns please do not put your social security number on your check, only your registration number. Local #13 will make every attempt to contact any member whose dues are in arrears. After 60 days you will be suspended and a \$500.00 reinstatement fee will be imposed. It is your obligation to the union to pay union dues on time.

MOST Annual Drug Testing Reinstated The MOST Board of Trustees have amended the Drug Policy to include annual testing. This new policy took effect on August 31, 2015. MOST sent renewal cards to everyone who hasn't tested from February 1, 2013 to the present so they know that they need to test. Anyone who does not comply with the new policy by that date will move to the ineligible list until a negative drug screen has been completed and received by the MOST office. New TWIC Enrollment Requirements Effective July 1, 2015 the Transportation Security Administration (TSA) has adopted new enrollment requirements for U.S. born TWIC applicants. TSA is making this change to align TWIC proof-of-citizenship requirements with those of other TSA Programs. Before applying for a TWIC card, be sure to visit www.tsa.gov to review the updated list of acceptable documentation.

Building Trades National Medical Screening Program Over the years, many workers in the trades, including Boilermakers, have worked at a Department of Energy site where they may have been exposed to hazardous materials. It is vital that those who worked at such sites be informed of the Building Trades National Medical Screening Program (BTMed), which provides FREE medical screening. BTMed is run by CPWR, the Center for Construction Research and Training, and is supported by the Building and Construction Trades Department, AFL-CIO. Members can call 1-800-866-9663 to find out if they are eligible for the free screening. For more information, please visit www.btmed.org.

TO ALL LOCAL LODGE PRESIDENTS, BUSINESS MANAGERS AND SECRETARY-TREASURERS IN THE U. S. AND CANADA

Re: Waiver of the Meeting Attendance Requirements for Eligibility for Nomination and Election as a Delegate or Alternate Delegate

THIS NOTICE IS TO BE READ AT ALL REGULAR AND SPECIAL MEMBERSHIP MEETINGS BETWEEN THE DATE OF THIS LETTER AND THE NOMINATION MEETING IN MARCH 2016, AND SUCH ACTION REFLECTED IN THE MINUTES

Brothers and Sisters:

Pursuant to Article 2.3.4 and Article 25.4.1.4 of the International Brotherhood Constitution, Local Lodge By-Laws may state that members must satisfy certain meeting attendance requirements to be eligible for nomination and election as convention delegates. However, the Department of Labor has held that the application of such requirements may be "unreasonable" where they disqualify a large portion of the membership.

We would prefer that every local lodge be allowed to abide by its by-laws without the threat of government interference. However, in order to assure that members in good standing are not "unreasonably" denied the right to be nominated and/or elected as delegates to the forthcoming convention (and to avoid the possible expense of re-running the convention), the International Executive Council has elected to waive all such meeting attendance requirements with respect to establishing eligibility for nomination and election as a delegate or alternate delegate to the Thirty-Third Consolidated Convention.

Accordingly, no local lodge shall impose the meeting attendance requirements to disqualify any member seeking nomination and election as a delegate or alternate delegate to this upcoming convention. All other conditions for eligibility, as prescribed in the International Brotherhood Constitution or your lodge's approved by-laws, shall still apply.

This Notice shall be posted at such locations (e.g. the union office, all job sites, shops, shipyards, etc.) and in a manner reasonably calculated to reach all members. Furthermore, if the lodge has not already mailed the nomination notice, such notice when mailed must include language advising that the attendance eligibility requirements are waived for this election only.
